

TERMS & CONDITIONS

1. THE ITEMS I/WE HAVE REQUESTED REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES TO BROKER ON MY / OUR BEHALF, HAVE TO THE BEST OF MY KNOWLEDGE BEEN ACQUIRED THROUGH LEGAL MEANS IN GOOD FAITH. I AM / WE ARE THE LEGAL TITLE HOLDER / S AND CAN SUBSTANTIATE THE POSITION.
2. THERE ARE NO OUTSTANDING PAYMENTS DUE ON THE ITEMS I / WE HAVE REQUESTED REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES TO BROKER FOR ME / US, EITHER ON ANY ONE ITEM OR WORK THAT HAS BEEN CARRIED OUT IN THE PAST.
3. SHOULD ANY OVERSEEN PAYMENT APPEAR IN THE FUTURE, I / WE WILL SETTLE THE DEBT IMMEDIATELY.
4. I / WE SUBMIT MY / OUR ITEMS IN FULL WORKING ORDER. I / WE ALSO ACKNOWLEDGE THAT UNDER THE SALES OF GOODS ACT MY / OUR ITEMS HAVE ALSO TO BE FIT FOR THE PURPOSE INTENDED, AND IN A CONDITION COMMENSURATE WITH AGE AND PRICE PAID FOR ITEMS.
5. ALL MY / OUR ITEMS OF EQUIPMENT ARE LEFT AT MY / OUR OWN RISK. I / WE WILL RELY ON MY / OUR OWN POLICY FOR ALL CLAIMS.
6. WHILST MY / OUR ITEMS ARE ON BROKERAGE WITH REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES I / WE WILL MAINTAIN ONE MILLION POUNDS THIRD PARTY LIABILITY COVER AND PROVIDE ALL MY / OUR OWN SECURITY DEVICES.
7. REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES ARE PERMITTED TO USE MY / OUR ITEMS FOR DEMONSTRATION AND TESTING PURPOSES ONLY.
8. I / WE UNDERSTAND THAT WHILST MY / OUR ITEMS ARE ON BROKERAGE WITH REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES, STORAGE MAY NOT BE FREE OF CHARGE. FOR DETAILS I / WE AGREE TO CONTACT REDDISH MARINE LIMITED.
9. I / WE WILL SPECIFY BELOW THE TYPE OF AGENT WE REQUIRE, EITHER SOLE / ONLY AGENT OR GENERAL / MULTIPLE AGENT.
10. ON COMPLETION REDDISH MARINE LIMITED SALES T/A SALCOMBE BOAT SALES SHALL BE ENTITLED TO DEDUCT COMMISSION THEREON FROM PROCEEDS OF THE SALE. COMMISSION RATES ARE VARIABLE, BUT ARE BASED ON TEN PERCENT UNDER FIVE THOUSAND POUNDS AND SEVEN PERCENT ON FIVE THOUSAND POUNDS AND OVER. PAYMENT WILL BE MADE TO VENDOR AT LEAST TWO WEEKS FROM DATE OF SALE.
11. I / WE HAVE PROVIDED REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES WITH THE FULLEST POSSIBLE PARTICULARS ON MY / OUR ITEMS AND TO INDEMNIFY REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES SHOULD THE INFORMATION I / WE PROVIDE TO BE INCORRECT.
12. I / WE SHALL INFORM REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES OF ANY CHANGE IN ASKING PRICE, LOCATION OR INVENTORY ETC.
13. REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES RESERVE THE RIGHT TO CHANGE BROKERAGE TERMS AND CONDITIONS WITHOUT PRIOR NOTICE.
14. I / WE WILL PROVIDE REDDISH MARINE LIMITED T/A SALCOMBE BOAT SALES WITH ALL SERIAL NUMBERS, RECEIPTS AND OTHER APPROPRIATE DOCUMENTS RELATED TO MY / OUR ITEMS.
15. VAT WILL BE CHARGED ON COMMISSION.
